4. Reports

G Andreazza queried whether the MDA Board would like a a presentation of the Lake Coolah / Lake Mejum Project.

- D Thurley indicated that it would be beneficial for the MDA Board members to see the presentation
- G Andreazza noted that they would at the very least like to see a feasibility study, so that the MDA
 could make a final decision on support of the project. Indicated that they were planning to meet
 with the Hon Sussan Ley MP.

4.1 Chairman's Report

The Chair provided a verbal report noting the recent meeting with Brad Ferris as part of the MDA's CSIRO partnership project on the Circular Economy.

The Chair noted the Hume Dam's capacity as above 90% following recent rainfall, indicated that the MDBA had called a meeting to discuss management of the Dam.

The Chair referenced Region 1's membership level, indicated that there is a feeling of disconnect between many councils in Region 1 due to the MDA's focus on water in the Murray, the Darling, and tributaries.

Referenced a recent Region 1 meeting which discussed water quality, specifically low oxygen levels and manganese levels affecting fish populations and water quality.

4.2 Chief Executive Officer's Report

The CEO provided his report for noting.

The CEO noted the conclusion of the BCLP on 31/3/22 with the MDA delivering required reports and project documentation on time. Indicated that the conclusion of the program required a BCLP report, which included an audit of the financial report, with a previous milestone report having been submitted in February 2020. The CEO noted a difficulty of documenting the two years between the Milestone 1 and Final Milestone 3 report, indicated that if the Final Milestone 3 report was successful, it would unlock the final grant payment of \$25,000.00.

- D Thurley queried whether the MDA had a means to list the participants and note what had changed their lives and community.
 - M Lamb affirmed, noted recent discussions with the Interim Treasurer Peter George regarding conducting a Dairy industry specific BCLP.

The CEO noted the MDA-CSIRO partnership project; The Circular Economy Market Analysis. Indicated that the CSIRO was working with Federal and State Governments but acknowledged that the real consultation and cooperation lay with Local Governments. Referenced recent meetings with Narromine Shire Council and AlburyCity Council, noted excellent progress.

The CEO indicated that the CSIRO intended to explore Water Quality and Plastics in future, noted that this offered an opportunity for the MDA to gain continued funding.

• D Thurley queried whether Wangaratta or Benalla may be a good venue option, encourage MDA interaction and membership.

- A Kassebaum noted that Region 5 had a large issue with Polypipe products and treated pine
 posts, queried whether there was something the CSIRO could do to address this issue.
 - M Lamb indicated that they were unsure what the CSIRO could do, noted that they
 were receptive to continuing the conversation outside of the board meeting.
 - A Kassebaum indicated that they might organise Tim Smythe to engage with M Lamb to discuss this issue further.

The CEO noted excellent progress with the 2022 78th National Conference. Indicated that the MDA had confirmed numerous Guest Speakers, including the Office of the Inspector-General for Water Compliance. M Lamb indicated that the MDA had received a grant from Destination NSW totalling to \$30,000.00 to be used for specific events and marketing.

The CEO referenced their recent attendance to a RAMJO meeting, noted the opportunity to promote MDA membership to RAMJO members.

7.2 MDA Membership and Engagement

The CEO noted that they had been engaging with councils virtually, but had put an emphasis on Inperson engagement. Referenced Berrigan Shire Council, which had recently withdrawn their membership. Indicated that the MDA had been engaging with the council with a potential of renewing their membership.

• C Davies queries whether a report could go out to all councils outlining the MDA's achievements and what had been happening over the 12 months. Indicated the benefit of sending this report out in advance of the Membership Renewal date.

7.3 Reports for Delegates

Region 9

G Andreazza noted that Griffith had been working on a \$24,000,000.00 sporting precinct to
host national events and full-time athletics. Credited the council for successfully sourcing
government funding.

Region 10A

- C Davies noted the MDA's CSIRO Circular Economy Market Analysis visit.
 - Indicated that the council had been focussing on the Circular Economy, with the Narromine Shire Council's investment in material distribution centre. Noted that following the meeting with the CSIRO, the council found a lot of synergies with the CSIRO's goals, and that there were opportunities for the CSIRO and the Narromine Shire Council to engage in the Circular Economy space.
 - Noted a perceived hesitancy from the EPA when it came to Waste-to-Energy projects, noted an opportunity for this to be raised at the upcoming council of Mayors.
 - Referenced issues facing the council in the Circular Economy space;
 - A Duopoly of waste management in NSW.
 - Referenced A Kassebaum's Polypipe and Treated Pine Posts, indicated that Narromine Shire Council had been approached by a business that would be able to treat these products.
- C Davies noted that Dams were at 120% capacity and rising following the wet weather. Noted a meeting on Wednesday to discuss releases from dams to mitigate winter floods.

Region 2

- D Thurley noted that the discussions of the EPA's perceived hesitancy had also been raised during the AlburyCity Council's meeting with the MDA. Noted a need to acknowledge that the technology had changed since old practices, a need to moderate practices to identify safe practices.
 - Indicated that AlburyCity council had signed a contract with Woolworths for treating their food waste.
