5.3 Location of 2019 AGM

2019 will be the 75th anniversary year for the AGM – a celebratory milestone that brings with it a wealth of opportunity for raising the profile of the MDA, and increasing membership and engagement.

Ms Bradbury proposed that Toowoomba could be a suitable host for the 75th National Conference and AGM, given Region 12, under the chairmanship of Mayor Richard Marsh and the Balonne Shire Council, had worked hard and made significant advances in raising the profile of Northern Basin communities at state and federal level among Southern Basin counterparts. Discussions with the Mayor Paul Antonio, and previously also with CEO Brian Pidgeon have indicated that Toowoomba Regional Council would be pleased to host the event, and work with MDA and Region 12 in preparing for it.

Cr Mansfield also raised the prospect of holding the conference in Canberra.

Recommendation: That the CEO investigate both Toowoomba Regional Council and Canberra as potential hosts of the 75th National Conference and AGM.
