Meeting held on May 26th. Guest speaker was Tom Chesson talking on the carp eradication programme and Di Meade called in from the MDBA to make a presentation regarding the progress of the Basin plan evaluation.

In the background, we have been working on the MDA AGM program and have had three meetings with the MDA CEO by phone link. The study tour in particular, is looking at being a very worthwhile series of experiences, very well matched to our theme & some (a visit to the 1968 State Proposal to build a dam on the Chowilla Dam Site) will bring back memories for some of one of the many 'political' disputes / decisions which shaped our water policy over many years. # Region 7 Report

A regional meeting was held on 29 June at Mitcham Council. The CEO attended via computer link. 20 people attended.

Two presentations were given. The first, by Mitcham council, outlined work they are successfully trialling for pervious paving on footpaths and roads together with other measures to improve water efficiency in parks and gardens. The second was an MDBA update by Di Mead, also using computer link. Both were well received by those present generating much discussion and questions.

It was decided that, for the most part, future meetings will held in the evening. I am now putting together a schedule of meetings for the next 12 months.

I have now developed a value proposition document for why Adelaide metro councils should be members of MDA. The CEO had input into this. I will be using it as I approach councils in Adelaide who are not members.

I have started work on the region's regional plan framework and will be linking this to our endeavour to document the water saving measures undertaken by local and State governments to reduce demand on River Murray water. I am looking at applying for a research grant through the SA LGA to assist with this work.

I am also meeting with the LGA to encourage the holding of a cross regional SA forum prior to the MDA AGM.

Our August meeting will include consideration of any motions for the AGM from Region 7.

We continue to work with councils to determine whether they are included in the correct region. For example, it appears Mt Barker is better aligned with Region 6, however, Adelaide Hills perhaps better belongs in Region 7.

I have also spent a lot of time with the CEO trying to get our records aligned between our local records and those held by the MDA office.

# Finance Report – June 2017

# Objective

To inform the Board of the financial affairs of the Association.

**Financial Report** 

Given the early timing of this month's board meeting, and the fact that preparing true and fair financial

reports takes a little time, this short update is provided to inform the Board about our financial position.

At this stage, nothing has emerged to indicate that we have not met our budget expectations for 2016-17. We therefore expect that our underlying free cash position will have improved during the year.

One key cashflow benchmark achieved is that we will not need to access our term deposit funds, because our working cheque account has a relatively healthy balance. Following our process of emailing membership invoices in early June (those invoices were dated 1 July, as normal), we received some \$55,000 of member payments prior to 30 June.

In addition, we made the last accrued rental payment to Parks Victoria, meaning that all the old liabilities that MDA had accumulated during the past two and more years have now been fully cleared. Other than accrued expenses for June, and a couple of small Flood DVD debtors, the Board will have a clean Balance Sheet at the commencement of the new financial year.

We expect to have complete pre-audit financial statements completed before 30 July, and will circulate these together with an explanatory note to put them in context.
