## MDA MOTIONS ANNOUNCED

From renewable energy to carp control, flows at Barmah Choke and management of Menindee Lakes. From regulatory compliance to socio-economic neutrality and the 450GL upwater; and even the take and use of water for bottling. Councils from across the Murray Darling Basin will consider these issues and more.

The MDA has today released the motions proposed by councils and other members to be debated when the national peak body for local government across the Basin holds its 74<sup>th</sup> annual meeting on Thursday, August 30 in Leeton NSW.

Topics covered in the proposed motions include:

- River flows during periods of high tourism activity;
- Victorian legislation regulating the take and use of water for bottling
- Continuing support for the National Carp Control Plan;
- Capacity of the Barmah Choke to meet Basin Plan objectives;
- Defining socio-economic neutrality in the context of the Basin Plan;
- Climate vulnerability modelling;
- Upgrading SA's outdated weir infrastructure;
- The creation of a National Water Registry;
- The creation of a National Water Ombudsman;
- Mandated role for local government in Basin Plan consultation and decision making;
- Protecting flows for the Barwon/Darling River;
- Replenishing the National Water Infrastructure Development Fund;
- Renewable energy hydro-electricity at Torrumbarry;
- Management of water in the Menindee Lakes;
- Community-based solutions for structural adjustment; and
- Murray Darling Association's regional boundaries.
