It was wonderful to see the tenuous but growing sense of optimism across these communities arising from recent rains and inflow. This is a refreshing relief after the years of debilitating drought, fish kills, wild bush fires and Covid-19.

We at the MDA recognise as well as any, and perhaps more than many, that any consultation can only occur with the generosity of time, information and knowledge of the people being engaged. We appreciate this generosity and have developed a process to guide and report on our engagement that aims to give best value and respect to those we engage with.

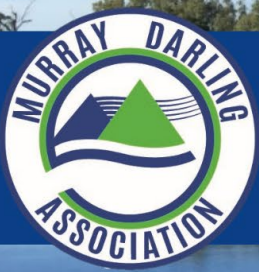

Sound relationship between Dubbo Regional Council and smaller water dependent councils is valued.

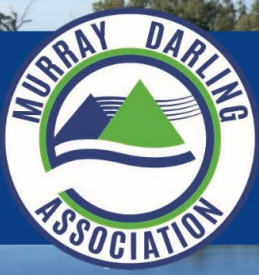

Deep respect for the rich Aboriginal history, artefacts, and continuing custodianship of the Baarkanji.

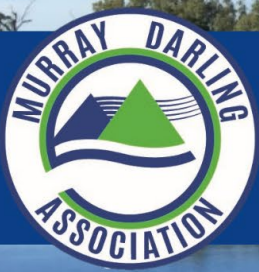
